Subject: Proposal for 12-B status – Regarding.

Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC Expert Committee on 15-16th February, 2020 to consider the proposal. The Report of the Expert Committee alongwith the compliance submitted by the University was placed before Committee of UGC members for consideration. The Committee recommended as under:-

“The Committee considered the report of the UGC's Expert Committee along with the compliance submitted by the University.

The Committee decided to recommend approval of 12 B status to Jayoti Vidyapeeth Women's University, Vedant Gyan Valley, Village- Jharna, Mahala- Jabner, Link Road, Jaipur-Ajmer Expressway(NH-8), Jaipur, Rajasthan (Private University) subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.

The University is advised to get NAAC accreditation at the earliest.

The faculty sanctioned and in position should be as per concerned statutory council(s)/ UGC norms. The University to ensure that the designation of the faculty members should be in line with UGC norms, academic grade pay is paid to the teachers and the service terms & conditions are mentioned in the offer/appointment letters.”

The above recommendations of the Committee along with the Report of the UGC Expert Committee were placed before the Commission in its 548th meeting {item No.1.02(a)(iii)} held on 09th September, 2020. The Commission considered and approved the recommendations of the Committee.
