

## AGREEMENT OF COOPERATION

**LUM University of Casamassima-Bari (Italy) and the Jayoti Vidyapeeth Women's University, Jaipur (JVWU) in recognition of their common interest in developing bilateral relations and convinced that cooperation between universities contributes to cultural enrichment, scientific progress, and the consolidation of friendship between countries, agree to establish the following Agreement of Cooperation.**

LUM University of Casamassima (Italy), represented by its President of Board of Directors Prof. Emanuele Degennaro, and Dr. Panckaj Garg, represented by its Chairman (Ex-Officio) Board of Management Prof. Vidushi Garg, concluded the following agreement with the aim of mutually beneficial cooperation continuation in education and science sphere

### GENERAL STATEMENT

This Agreement of Cooperation will promote activities in the following principal areas:

- Exchange of students
- Exchange of faculty and academic staff
- Exchange of staff (administration, library, services...)
- Collaborative research, instructional and cultural programs, including publication activities of mutual interest, exchange of bibliographic materials and shared access to information networks, organisation of international conferences and participation in international research/innovation projects.

All activities developed under the auspices of this Agreement will respect and conform to the corresponding norms, traditions, and regulations of each University.

### Article 1

1. Object of Agreement is development on the basis of equal rights possession and mutually profitable cooperation in different spheres of university life.

### Article 2

2.1. Parties agree to the following general forms of cooperation:

- to cooperate in the field of scientific work through the organization of **joint scientific research** on mutually agreed topics, the exchange of scientists, including those with a high Hirsch index, and the publication of joint scientific works, developing and maintaining contacts between departments, laboratories and other scientific departments;
- to perform the **exchange of students, scientific workers and academic staff**, rendering them all necessary conditions for enlarging theoretical and practical knowledge
- to develop **joint study programs**;



- to take part on mutually bases in **scientific conferences, seminars**, that are held by one of the sides, and to represent results of scientific research in periodical and scientific publications of Sides;
- to provide with assistance in **training of academic teaching staff** through courses of vocational training of doctorate, post-doctorate and master;
- to provide the opportunity of scientific and/or professional practice (**internship**) to teachers, staff and students;
- to work together in the **technology transfer to the social community** of the region **where the university is located, respectively**; Jayoti Vidyapeeth Women's University Campus at **Vedaant Gyan Valley, Village-Jharna, Mahala Jobner Link Road, NH-8 Jaipur Ajmer Express Way, Jaipur-303122, Rajasthan** and **LUM University in Apulia region**, in order to carry out the following objectives:
  - ✓ Recognition of Local Tradition & Culture
  - ✓ To Explore & Marketing of Local Talent & Culture
  - ✓ Correlation & Integration of Traditions & Research
  - ✓ Local Skill Exchange
  - ✓ Virtual Interaction between Local, Businessman, Entrepreneurs for knowledge & Feeling share
  - ✓ Integrative Health Care Chair

2.2. It is not excluded that cooperation of Agreeing Parties can be arranged in sphere of university policy and administration by organization staff exchange in this activity sphere for experience exchange and interuniversity cooperation results summing up.

### Article 3

3.1. Present Agreement doesn't exclude other forms of cooperation that can be proposed for discussion by initiative of one of the parties, and also might be completed and changed in written form and signed by representatives.

3.2. Terms of joint activities, the conditions for utilizing the result achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific activity. It is also understood that any financial arrangements will be negotiated and agreed to in writing for each specific case and will depend upon the availability of funds.

3.3. For realization of statements of present Agreement Agreeing parties can develop and approve new Work programmes of cooperation, in which there might be pointed concrete forms, scientific topics, terms and quota of cooperation, and also order and condition of its organization and financing.

3.4. This Agreement does not confer any legal right or obligations on both Universities.

3.5. Each University will name a liaison person who will be responsible for coordinating activities related to this agreement:

- on behalf of **LUM University of Casamassima-Bari (Italy) Prof. Patrizia Guida, Vice-Rector for the International Relations**, in her personal capacity shall be the coordinating person for the implementation of this Agreement,

- on behalf of Jayoti Vidyapeeth Women's University, Jaipur (JVWU) Dr. Panckaj Garg, Founder & Advisor of the University in his personal capacity shall be the coordinating person for the implementation of this Agreement.

3.6. Travel and lodging expenses will be paid by the sending institution.

3.7. Each participant will purchase the medical and accident insurance required by the host or receiving institution.

#### Article 4

4.1. The present Agreement is established for a period of five years, effective on the date of signing.

4.2. At the end of the five year period, the agreement will be automatically renewed, unless the Parties provide written notification of a decision of non-renewal prior to the expiration date.

4.3. Parties can dissolve present Agreement at pre-term period, informing in written form about their intentions other Party, but not later than before three months till present Agreement expiry date.

4.3. Present Agreement is concluded in two examples both possessing equal legal power, one example for each Party.
