AND

**Second Party:** MIDDLE EAST HOSPITAL (hereinafter referred to as MEH), a health service provider incorporated under the laws of the Kingdom of Bahrain with a valid Commercial Registration Certificate No. 72349-1 and NHRA License No. 30301538 with address at Bldg. 105, Road 28, Block 328, P.O. Box 1713, Segaya, Kingdom of Bahrain

### **PREAMBLE**

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS CONTAINED HEREIN, BOTH THE PARTIES AGREE THE FOLLOWING: -**

1. The term of this Agreement shall be 01 calendar years commencing from 01 Nov 2020 and shall expire on 31 Oct 2021.

  - 4.1 The "First Party" hereby undertakes and warrants to "Second Party":
    - 4.1.1 That any information supplied by the "First Party" is accurate, complete and true;





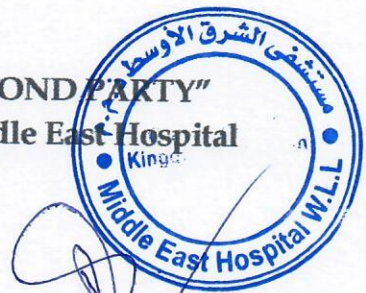
- 4.1.2 That no information supplied by the "First Party" contains any data, image or other material which;
